Arts and Cultural Impact Grants are available to nonprofit organizations seeking support for public arts and culture projects/programs up to \$5,000 per year.

We have two cycles for this grant program - Spring and Fall. Organizations may only receive one grant per year and must have completed their previous grant's final report before submitting a new application.
